## **Notice** Call for applications for local drinking water source protection committee – Agriculture Sector (2) and Environment (1)

Applications accepted until Monday, September 25, 2017

The Ausable Bayfield Maitland Valley Drinking Water Source Protection Committee (SPC) is a 15-member committee reducing risk to local municipal drinking water sources. It achieves this through implementation of effective, practical, locally developed, provincially approved plans.

One third of the committee (five members) comes from economic sectors as per *Ontario Regulation 288/07* of the Ontario *Clean Water Act, 2006*. Locally, three of those five economic member seats are from Agriculture.

Another third of the committee is from municipalities.

The other third of the committee represents Other – Environmental, Health, and other interests of the general public.

The Ausable Bayfield Source Protection Authority, on behalf of the region, is seeking applications for three individuals to serve on the committee. There are two (2) vacancies for committee members from the *Economic – Agriculture* sector; and one (1) vacancy for a committee member from *Other – Environmental public interest*.
